## **Section 2. Parent Information**

### **Young Children**

Young children are often upset when you first leave them at the crèche. The following will help staff comfort and support your child through the settling in period and beyond:

- Your child will be assigned to a member of staff who will be responsible for ensuring their needs are met.
- Bring a favourite toy, blanket, dummy or other object that your child associates with home.
- Bring your child's buggy/car seat and a blanket so that your child can rest or sleep in comfort and safety.

#### The Formalities

- On day one, fill in our Registration Form that contains important information about your child. Bring this with you or email to annascott@cheekychopschildcare.co.uk
- For safety and security, sign your child in on arrival and out when they are collected.
- Let crèche staff know if someone else is picking up your child e.g. Grandma.
- Bring a bag with spare clothes, nappies and wipes.

#### **Infants**

- Bring your baby's milk feed and any weaning food, if appropriate.
- Let staff know about their feeding and nappy change routine.
- Bring your child's car seat or buggy so that they can sleep if required.
